## RAGGING AWARENESS AND INFORMATION

The Karnataka Education Act, 1983 (Karnataka Act No.1 of 1995) Section 2 (29) defines ragging as

“Causing, inducing, compelling or forcing a students, whether by way of a practical joke or otherwise, to do any act which detracts from human dignity or violates his person or exposes him to ridicule or forbear form doing any lawful act, by intimidating, wrongfully restraining. Wrongfully confining, or injuring him or by using criminal force to him or by holding out to him any threat of such intimidation, wrongful restraint, wrongful confinement, injury or the use of criminal force”

The Karnataka Education Act, 1983 (Karnataka Act No.1 of 1995) section 116 lays down the penalty for ragging.

“No person who is a student in an educational Institute including on institution under the direct management of the university or of the Central Government shall commit ragging.

“Any person who contravenes sub section (1) shall, on conviction, be punished with imprisonment for a term which may extend to one year or with fine which may extend to two thousand or both”

Ragging is a criminal offence punishable under many provisions of the Indian Penal code, also. In addition to prosecution, students committing the act of ragging are also liable to being rusticated, dismissed and expelled from the college. The marks cards, character certificates and degree certificates of such students are also liable to be embossed in bold letters to the effect that he/she had indulged in ragging.

Students of second, third and final year are warned to desist from ragging strictest possible disciplinary action will be taken against those found to indulge in ragging.

The students are also required to give an undertaking in the prescribed format to the college office, whenever demanded.
