DOCUMENT FOR REDRESSAL MECHANISM COLLEGE OF DENTAL SCIENCES

Our institution has a transparent mechanism in place for the timely redressal of student grievances and the prevention of sexual harassment and ragging. The following are some of the steps that institutions take to ensure a smooth redressal process.

Set up Committees - The institution has set up committees to deal with complaints of student grievances, sexual harassment and ragging. The committees are composed of faculty members and student representatives.

- ➤ We have a designated **Student Grievance Redressal Committee** that receives and addresses student grievances.
- ➤ In order to prevent incidents of sexual harassment, we have set up an **Internal Complaints**Committee that deals with complaints of sexual harassment.
- ➤ To prevent incidents of ragging on campus, our institution has formulated an **Anti-Ragging**Committee to monitor and prevent incidents of ragging on campus.

<u>Maintenance of confidentiality:</u> In order for the victim to feel safe, confidentiality of the issue is compulsorily maintained.

The matter will be taken to Head of the institution confidentially and resolved through convenor of the committee

Formulate Policies - The institution has policies to prevent and address incidents of sexual harassment and ragging. The policy clearly defines what constitutes sexual harassment and ragging, and the steps to be taken in case of any such incident.

Conduct Awareness Campaigns - The institution conducts regular awareness campaigns to educate students about their rights and about the negative effects of sexual harassment and ragging. This will encourage students to come forward and report any grievances they may have.
