- As per section 11.3 of the aforesaid regulations, the authorities/Management (Trust, Societies, etc.) of the institution, particularly the Head of the institution, shall be responsible to ensure that no incident of ragging takes place in the institution. In case any incident of ragging takes place, the Management/Head shall take prompt and appropriate action against the person(s) whose dereliction of duty lead to the incident. The authority designated to appoint the Head shall, in its turn, take prompt and appropriate action against the head.
- 3. It is also to inform you that if an institution fails to curb ragging, the Dental Council of India, as per section 11.4 of Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, shall impose any one or any combination of the following penalties on it:
  - To initiate the derecognition process against the institution under section 16A of the Dentists Act, 1948.
  - 11.4.2 To reduce the admission capacity of the institution to the extent to which the Council deem fit.
  - 11.4.3 To stop further admission in the institution till further orders.
  - To stop renewal of permission in respect of UG/PG Dental Courses. 11.4.4
  - To post the information regarding penalties so imposed on the concerned 11.4.6 institution on the website of DCI for information of all concerned.
